Developments of the NSDI in Republic of Kosova

- ◆ Under the Law on Cadastre, No.04/-L-013, Article 23, Kosova Cadastral Agency is responsible for coordination and creation of NSDI in Republic of Kosova;
- ◆ For better coordination between all stakeholders producing the spatial data in Kosova, Government has established a Inter- ministerial Committee for the Land Administration and NSDI;
- ◆ Kosova Cadastre Land Information System (KCLIS), is a unified multi-purpose system for Kosova wide use, in cooperation with data providers and users;
- ◆ Completed module for graphical part Cadastral Map (KCLIS-grafic), and started implementation in municipal cadastral offices. Started migration of data formats, ITF (INTERLIS), shapefile, DWG and acces. And will be connected to part text (KCLIS - text)
- ◆ Kosova Cadastral Agency is implementing the project for establishment of unified Address Register in entire Republic of Kosova;
- ◆ Kosovo Cadastral Agency has launching of National GEO-PORTAL, which will be a common access point for all electronic services available within NSDI ;
- ◆ Kosova Cadastral Agency has established a Unit for NSDI within its organizational chart.



New Legal Framework

- ◆ Law on Cadastre No.04/-L-013;
- ◆ Law on Amendments and Supplements to the Law on the Establishment of Immovable Property Rights Register (IPRR), No.04/-L-009;
- ◆ Law on Address System, No.04/-L-071
- ◆ Law for NSDI in Republic of Kosova



It is expected that NSDI in Republic of Kosova will be fully operational within the next three years, provided that there will be:

- More public awareness campaigns about the role of NSDI;
- Building more professional capacities for NSDI;
- Full coordination about NSDI within relevant institutions (stakeholders);
- Adopted National Strategy for NSDI;
- Completed data standardization in the public and private sector etc.





Cooperation with countries in the region:
